



Resolution No. 002414 of 2015 from the National Superintendence of Health

Resolution 00001 dated 25 November 2015

Liquidation Process of SaludCoop.

Dear Clients,

We are writing this time to advise you in connection with the liquidation process of the E.P.S. SaludCoop, which was started under Resolution 002414 of 2015 from the National Superintendence of Health.

In the aforesaid Resolution, the National Government decreed to take immediate possession through the National Superintendence of Health of all properties, assets and businesses and the intervention of SALUDCOOP ENTIDAD PROMOTORA DE SALUD ORGANISMO COOPERATIVO, with Taxpayer Identification Number (NIT) 800.250.119-1.

The following are the main aspects of such Resolution:

- Take possession of SALUDCOOP for a term of two (2) years.
- Designate Luis Martin Leguizamón Cepeda identified with citizenship card number 79.405.054, as Special Inspector Liquidator Agent.

On the second (2nd) day of December, 2015 and by means of a writ publication was made of Resolution 00001 dated 25 November 2015: **“WHEREBY A TERM IS ESTABLISHED FOR TIMELY FILING AND LATE FILING OF CLAIMS IN CONNECTION WITH THE LIQUIDATION PROCESS OF SALUDCOOP EPS EN LIQUIDACION IDENTIFIED WITH NIT 800.250.119-1 AND HAVING ITS MAIN DOMICILE IN THE CITY OF BOGOTA D.C.”**

In regard to **CREDITORS**, the following was provided under the aforesaid Resolution:

*“All natural persons or legal entities of a public nature (ICBF, SENA, DIAN, Ministry of Health and Social Protection, National Superintendence of Health, General Prosecutor’s Office, Territorial Entities, among others) **or private nature that hold to be entitled to file claims of any kind** (including any third party asserting that such entity has properties whose ownership is held by such third parties and the same must be returned) against SALUDCOOP ENTIDAD PROMOTORA DE SALUD ORGANISMO COOPERATIVO EN LIQUIDACION, identified with NIT 800.250.119-1, so that **the same may appear to file their claims in a TIMELY manner with at least summary evidence of the credits thereof** only at the branch located at Calle 128 N° 54 – 07, Prado Veraniego Borough in the city of Bogotá **DURING THE TIME PERIOD RUNNING FROM 18 DECEMBER 2015 TO 18 JANUARY 2016, Monday to Friday from 8:00 a.m. to 12:00 m and from 2:15 p.m. to 5:00 p.m.**; in regard to securities related rights, it will be necessary to submit the original security. PLEASE NOTE that after 19 January 2016 those that failed to file a claim in the aforesaid time period may file their claims **DURING THE TIME PERIOD RUNNING FROM 01 FEBRUARY 2016 UNTIL 12 FEBRUARY 2016, Monday to Friday**”*



from 8:00 a.m. to 12:00 m and from 2:15 p.m. to 5:00 p.m., to this end, the claims so filed will be rated and classified as LATE-FILED.

The above clearly means that any credit right already declared and whose existence is not disputed may be collected from the eighteenth (18th) day of December until the eighteenth (18th) day of January, 2016 as per the terms of Resolution 00001 dated 24 November 2015.

Finally in regard to those rights that have not been paid by SaludCoop as leaves and incapacities, we recommend to resort directly to the National Superintendence of Health invoking its jurisdictional function in order to obtain payment of the right backed up by the title of execution (ruling) and thus become a party to the liquidation and secure such payments.
